Scope of Competitive Procedure:** The selection of an Implementing Body engaged for the implementation of the activities of the programme: *MEDITERRANEAN COMBO* Information provision and promotion measures on fruits and vegetables in the internal market of EU, submitted under the Topic MULTI-A-2020, within the framework of the Regulation (EU) No 1144/2014 of the European Parliament and of the Council. - 4. Place of performance:** Greece, Spain, Germany and Hungary.

Conditions for participation:** Participation is open on equal terms to all natural or legal persons (legal entities or consortium of entities) of the Member States related to promotion, advertising, marketing and consultancy services and operating legally in EU Member States or within the European Economic Area (EEA), or Third Countries that have signed the Government Procurement Agreement of World Trade Organisation.
